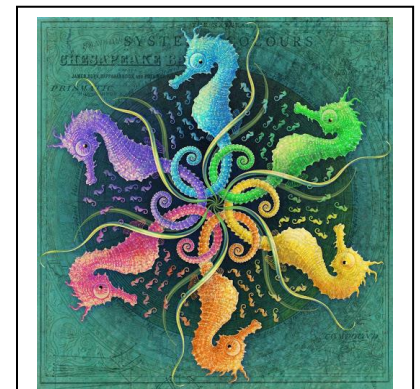

Annual Meeting Registration

Units in good standing are entitled to be represented at the annual meeting by its president or alternate and one (1) voting delegate for every twenty-five (25) members, based on this year's membership numbers as of 3/31/21. Each Council may be represented by its president or their designated alternate. Additional members may be sent as non-voting delegates.

**** For example - ABC PTA has 100 members. ABC president and four delegates may vote. Designate on the registration link if you are a voting member.

Remember that this does not limit the number of people who may attend, only the number who may VOTE at the annual business meeting. All PTA members, parents, teachers and other interested parties are invited to attend.
